Abstract Instructions

English is the official language of the conference. Individuals can serve as an author on multiple abstracts; however, an individual may present no more than two accepted abstracts. You will be notified of the decision and presentation format (oral or poster) via email by June 30, 2020. All abstracts will be distributed to conference participants and will be freely available in pdf format on the conference website. Unless otherwise specified, the first author will be considered as the presenting author. All attendees and presenters must register for the conference.

Directions for Abstract Submission

Place each abstract on a separate page. The word limit for the abstract body is 350 words (excluding title, authors, and affiliations). Please use Arial 11 font and single spacing. Your abstract must include the information below.

Title - Please use both upper- and lower-case letters in the title (LIMIT is 15 words).
Type of Presentation – Indicate oral, poster, or either presentation
Authors - List full name of each author.
Institutional Affiliations - List the primary institutional affiliation for each author. numbered
Body – Use separate paragraphs for each section -- Objective, Methods, Results, Conclusions. Do not include figures and tables.
Presenter – Include name and email address of presenting author.

Abstracts must be received no later than Midnight (CDT –USA) April 15, 2020.
